The strips of land shown as roads upon lands owned by the United States of America are to be made the subject of a grant of easement for road purposes by separate instruments to be duly recorded.

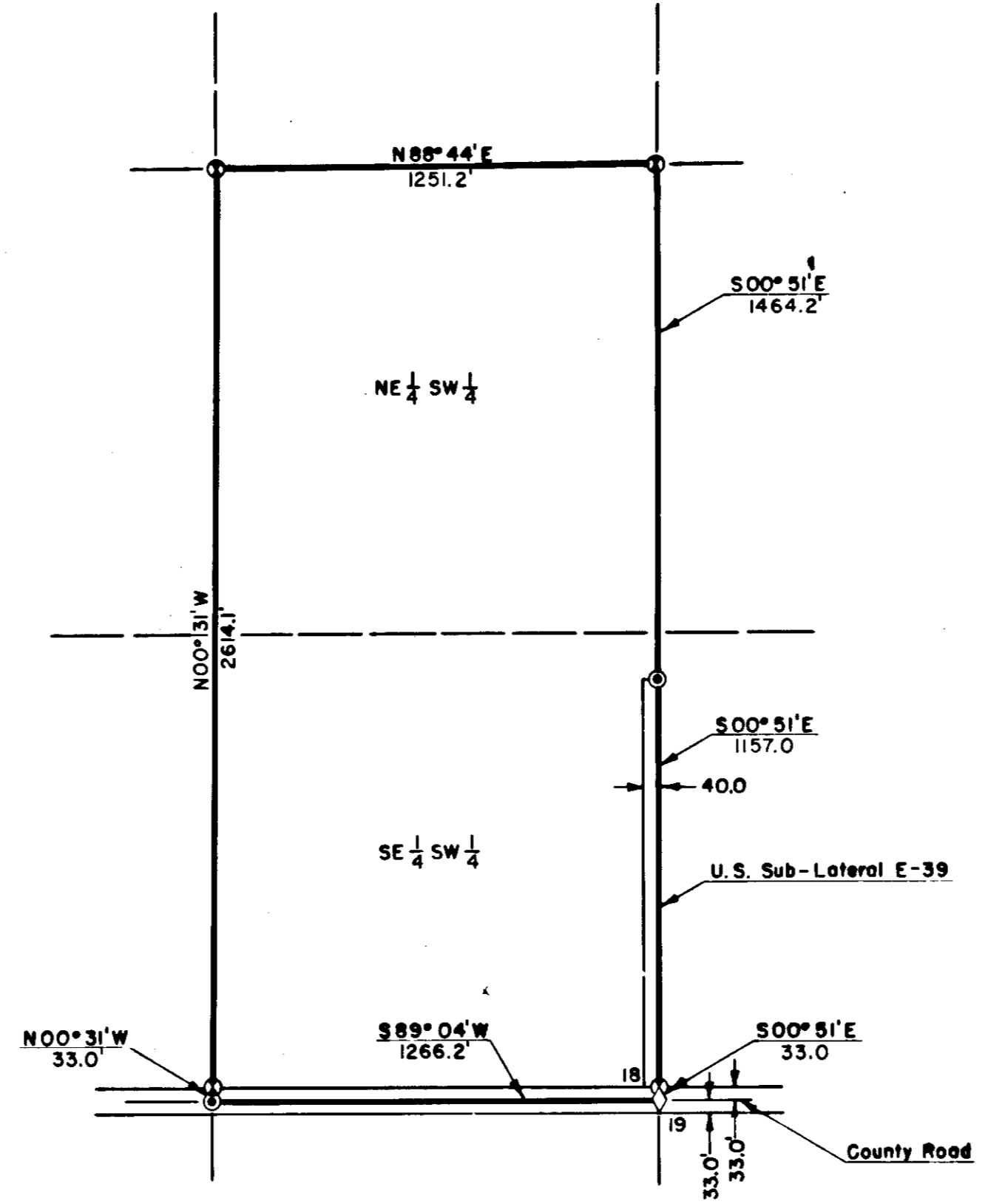

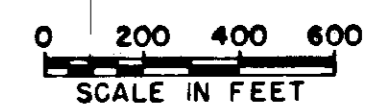
