


STATEMENT OF SUBDIVISION

EDEN VALLEY PROJECT Sweetwater County, Wyoming

The subdivision of the Eden Valley Project as it appears on this plat is made with the free consent and in accordance with the desire of the United States of America as owner and proprietor thereof, pursuant to the provisions of the Acts of Congress of May 10, 1939 (53 Stat. 685, 719), of June 20, 1949 (63 Stat. 277), and of May 20, 1954 (68 Stat. 155), under delegation of authority contained in Title 7, Code of Federal Regulations, Section 600.6, as revised November 17, 1955 (20 F.R. 8517). The strips of land shown as roads upon lands owned by the United States of America are to be made the subject of a grant of easement for road purposes by separate instruments to be duly recorded.
