

KNOW ALL MEN BY THESE PRESENTS

That Earl F. Wilson does hereby certify that the Wilson Addition to the Town of Granger, Sweetwater County, Wyoming is located in the SW 1/4 SEC 29 of Section 29, Twp 19 North, Range 111 West, 6th P.M. and is more particularly described as follows: Beginning at the south westerly corner of Lot 13-Block 1 of the Original Plat of the Town of Granger, Wyoming, thence southwesterly (S 41° 20' W) along the southeasterly line of Blocks 2 and 3 a distance of 496.0 feet more or less to a point on the south line of said Section 29; thence EASTERLY (S 89° 40' E), along said section line, a distance of 286.2 feet to the southwesterly corner of Lot 5-Block 1 of this Wilson Addition; thence Northeasterly (N 41° 20' E) along the southeasterly line of Lots 3 and G-Block 1 a distance of 59.17 feet; thence N 51° 05' W-17.50 feet to the southwesterly corner of Lot 7, the Town Cemetery tract; thence N 22° 45' E-103.5 feet to an angle point in the cemetery fence; thence N 0° 28' W, along the said fence 60.0 feet to the most easterly corner of the cemetery; thence S 41° 20' W, along the north-easterly line of the cemetery-100 feet more or less to the southeasterly corner of Lot 1 of this addition; thence North 48° 40' W-76.0 feet to a point on the southerly line of Third Street; which street line is parallel with and 50 feet southeasterly of a right angle from the southeasterly line of Blocks 2 and 3 of the Original Plat; thence N 41° 20' E-207 feet; thence N 48° 40' W-50.0 feet to the point of beginning.

That this addition as appears upon this plot is made with the free consent and in accord with the desires of the undersigned owner, that the foregoing is a correct plot of said addition, as staked into lots, block and street, and the dimensions are correctly shown by figures representing feet and decimals of a foot, and the courses are correctly shown hereon.

The undersigned owner hereby dedicates to the public use the street shown hereon.
