


DEDICATION



KNOW ALL MEN BY THESE PRESENTS: THAT NORTHWEST HOMES, INC., A CORPORATION DULY ORGANIZED AND EXISTING UNDER AND BY THE LAWS OF THE STATE OF WYOMING, DOES HEREBY CERTIFY THAT THE FOREGOING "HUTTON HEIGHTS ADDITION TO THE TOWN OF GREEN RIVER (FOURTH FILING)" IS A PLAT OF LAND IN SWEETWATER COUNTY, WYOMING, AS LOCATED IN THE SOUTH HALF OF SECTION 22, T18N R107W 6TH PM, AND 5 MORE PARCELS, DESCRIBED AS FOLLOWS:

THE POINT OF BEGINNING, WHICH IS THE 1/4 CORNER OF SECTION 22, LON. N 61° 36' E, A DISTANCE OF 846.00 FEET TO A POINT NO F4-1; THENCE N 61° 36' E, A DISTANCE OF 2000 FEET TO A POINT NO F3-10; THENCE S 74° 02'E, A DISTANCE OF 839.60 FEET TO A POINT NO F4-2; THENCE S 74° 02'E, A DISTANCE OF 839.60 FEET TO A POINT NO F4-3; THENCE S 63° 12'E, A DISTANCE OF 473.06 FEET TO A POINT NO F4-4; THENCE S 63° 12'E, A DISTANCE OF 116.45 FEET TO A POINT NO F3-7; THENCE S 63° 12'E, A DISTANCE OF 183.46 FEET TO A POINT NO F3-8; THENCE S 49° 16'E, A DISTANCE OF 120.00 FEET TO A POINT NO F4-5; THENCE S 49° 16'E, A DISTANCE OF 511.3 FEET TO A POINT NO F3-11; THE NORTHERN POINT OF THE HUTTON HEIGHTS ADDITION TO THE TOWN OF GREEN RIVER (THIRD FILING).

THE LINE CONTINUING ALONG SAID BOUNDARY S 58° 25' E, A DISTANCE OF 2000 FEET TO A POINT NO F3-10; THENCE CONTINUING ALONG SAID BOUNDARY S 58° 25' E, A DISTANCE OF 655.00 FEET TO A POINT NO F3-11; THENCE CONTINUING ALONG SAID BOUNDARY S 14° 02' W, A DISTANCE OF 183.46 FEET TO A POINT NO F3-7; THENCE CONTINUING ALONG SAID BOUNDARY ON A 14° 02' CIRCULAR CURVE TO THE RIGHT, THE RADIUS OF WHICH IS 555.00 FEET, THENCE ALONG SAID CURVE AND CONTINUING ALONG SAID BOUNDARY A DISTANCE OF 129.61 FEET TO A POINT NO F3-8.

THENCE CONTINUING ALONG SAID BOUNDARY N 61° 38' W, A DISTANCE OF 460 FEET TO A POINT NO F3-5; SAID POINT BEING ON A 74° 07' 20" CIRCULAR CURVE TO THE LEFT, THE RADIUS OF WHICH IS 210.00 FEET, THENCE CONTINUING ALONG SAID CURVE AND CONTINUING ALONG SAID BOUNDARY A DISTANCE OF 355.00 FEET TO A POINT NO F3-4.

THENCE CONTINUING ALONG SAID BOUNDARY S 28° 25' W, A DISTANCE OF 528.95 FEET TO A POINT NO F3-3; THENCE CONTINUING ALONG SAID BOUNDARY S 28° 25' W, A DISTANCE OF 250.00 FEET TO A POINT NO F3-2; THENCE CONTINUING ALONG SAID BOUNDARY S 28° 25' W, A DISTANCE OF 170.00 FEET TO A POINT NO F3-1.

NOTES: THE PARCELS CONTAINING LAND ARE 1/4 ACRES MORE OR LESS, AND THAT THE SURVEY AND STAKING THEREOF INTO LOTS, BLOCKS AND STREETS AS APPEARS ON THIS PLAT IS WITH THE FREE CONSENT AND ACCORDING TO THE DESIRES OF THE UNDERSIGNED OWNERS, AND THAT THE STAKES AND MARKS SET OUT ON THE SURFACE ARE THE POINTS GOING TO MAKE A CORRECT PLAT OF SAID SUBDIVISION AS SURVEYED AND STAKED, AND THAT THE STREETS AND STREETS ARE LOCATED AND SHOWN AS SHOWN, AND THAT THE DIMENSIONS OF LOTS AND BLOCKS AND WIDTHS OF DECIMALS OF A FOOT AND THE COURSES OF THE STREETS ARE CORRECTLY SHOWN THEREON, AND THAT NORTHWEST HOMES, INC.
