— KNOW ALL MEN BY THESE PRESENTS —  
 That whereas DUBET SMITH of the town of ROCK SPRINGS  
 State of WYOMING is the owner and proprietor of the following lots  
 or parcel of land situated in the town of ROCK SPRINGS county of  
 SWEETWATER and State of WYOMING — to wit:—  
 A certain lot of land lying in the NE 1/4 Quarter of the SW Quarter  
 of Section 36 in T19 N R 105 W of the 2nd Principal Meridian and more  
 particularly bounded and described as follows: To wit:  
 Beginning at point marked being on corner which is Marked B  
 6100' from the W corner between sections marked as T19 N R 105 W to  
 an iron pin placed in the NW corner of the same, thence North 1/4  
 400' to the place of beginning.  
 And whereas the said DUBET SMITH has subdivided the said lot or  
 parcel of land into blocks, lots and streets for the purpose of laying out  
 an addition to the town of ROCK SPRINGS in the county of  
 SWEETWATER, State of WYOMING as it shows on the annexed  
 plat and blocks and lots being numbered, and also streets being named  
 as is shown on said plat and the said blocks and lots being of the dimensions  
 length, and breadth, given upon the said plat, and also the streets  
 being of the width and courses indicated thereon. Now therefore, the  
 said DUBET SMITH, do hereby declare and give the said lot or  
 parcel of land into blocks, lots and streets as shown on an  
 addition to the town of ROCK SPRINGS in the county of  
 SWEETWATER and State of WYOMING, to be known as THE PROSPECT  
 HEIGHTS ADDITION TO ROCK SPRINGS, provided however that the  
 streets, hereinafter named and plat are hereby dedicated for  
 street purposes and for other purposes only and hereby accepting  
 and assuming the liabilities thereon, to-wit: to provide for each lot  
 to meet for one year the same of taxes, taxes of streets and  
 water charges or liability whatever thereon.  
 And the annexed and foregoing subdivision of the above  
 described lot or parcel of land as shown upon the annexed  
 plat made with the true intention and in accordance with the  
 desire of the said DUBET SMITH  
 In witness whereof the said DUBET SMITH has hereunto
