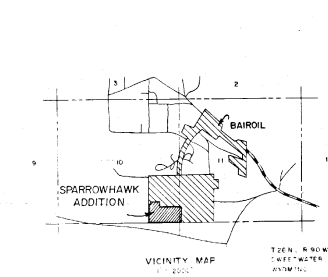
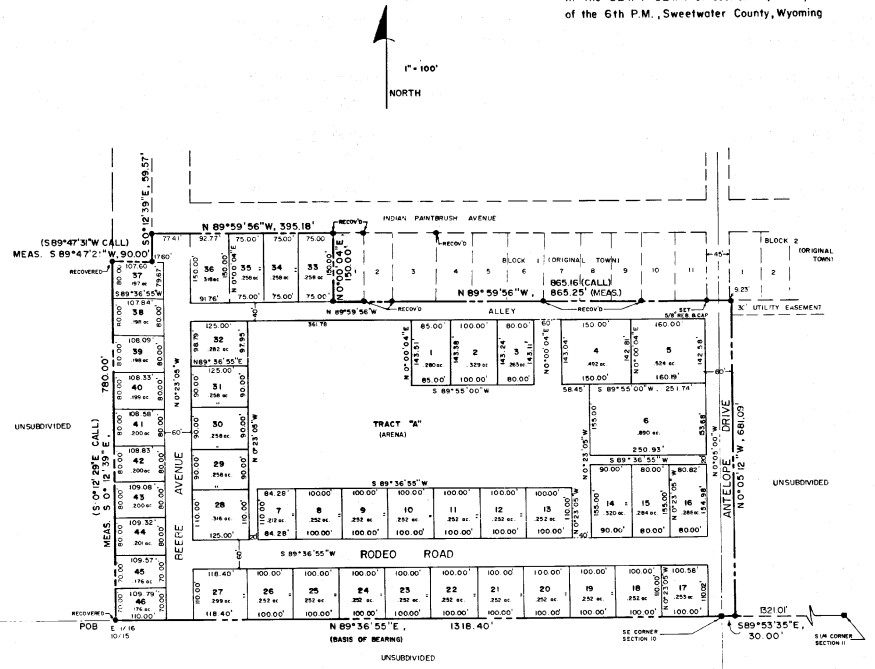


SPARROW HAWK ADDITION to the TOWN OF BAIROIL, WYOMING

In the SE 1/4 SE 1/4 of section 10, T26N, R90W,
of the 6th P.M., Sweetwater County, Wyoming



DEDICATION

KNOW ALL MEN BY THESE PRESENTS, that the undersigned owners and proprietors of the land shown on this plat hereby certify that the Sparrow Hawk Addition to the Town of Bairoil, Wyoming, is within the SE 1/4 SE 1/4 of Section 10, T26N, R90W, and the SW 1/4 SW 1/4 of Section 11, T26N, R90W, Sweetwater County, Wyoming, more particularly described as follows:

- Beginning of a point being the East 1/16 corner between Sections 10 and 11 of said T26N, R90W, said point being the SW corner of the said Sparrow Hawk Addition;
- Thence along the South line of said Section 10, N89°36'35"E, 138.40 ft. to a point being the SE corner of said Section 10;
- Thence along the South line of said Section 11, S89°53'35"E, 3000.00 ft. to a point being the SE corner of said Sparrow Hawk Addition and being on the East line of Antelope Drive;
- Thence N00°05'12"W, 681.00 ft. along the East boundary of Antelope Drive to a point being the South boundary of Lot 1, Block 2, Town of Bairoil;
- Thence N89°56'56"W, 865.25 ft. along the South boundary of Block 1, Town of Bairoil, to a point being the SE corner of Lot 23 of the said Sparrow Hawk Addition, said point also being the SW corner of Lot 1, Block 1, Town of Bairoil;
- Thence N00°00'04"E, 180.00 ft. along the West line of Lot 1, Block 1, Town of Bairoil, to a point being the NE corner of Lot 33 of the said Sparrow Hawk Addition, said point also being the NW corner of Lot 1, Block 2, Town of Bairoil;
- Thence N89°56'56"W, 195.18 ft. to a point on the East line of Well Reserve Site No. 8, Town of Bairoil;
- Thence S 00°12'30"E, 55.57 ft. along the East line of Well Reserve Site No. 8, to a point being on the North boundary of Lot 37 of said Sparrow Hawk Addition, said point also being the SE corner of Well Reserve Site No. 8;
- Thence S89°47'20"W, 90.00 ft. along the South line of Well Reserve Site No. 8, to a point being the SW corner of Lot 37 of said Sparrow Hawk Addition, said point also being the SW corner of said Well Reserve Site No. 8;
- Thence S00°12'30"E, 180.00 ft. to the point of beginning, said Addition containing 22.766 acres, more or less.

That the surveying and laying out in Blocks, Lots, Allots, Easements and Areas shown as Sparrow Hawk Addition to the Town of Bairoil, Sweetwater County, Wyoming, is with free consent and in accordance with the desires of the undersigned owners and proprietors.

That they are the owners thereof and that they do hereby dedicate to the public use said Streets, Allots, Areas and Easements they own on the foregoing plat.
