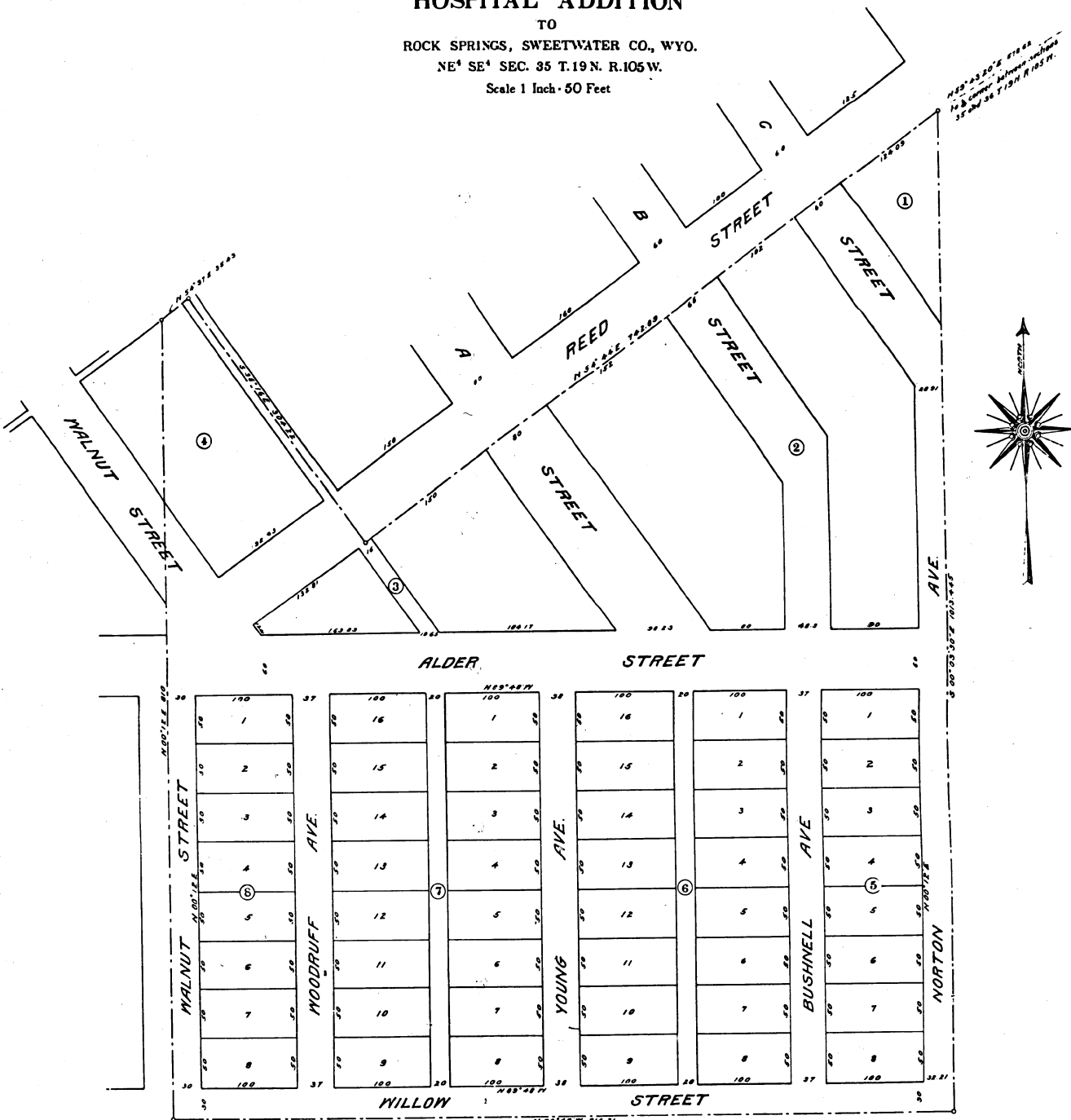


**AMENDED MAP

KNOW ALL MEN BY THESE PRESENTS: That the Rock Springs Realty Company, a corporation duly organized and existing under and subject to the laws of the State of Wyoming, does hereby certify that the above as foregoing blocks 1 to 16 of the Amended Hospital Addition to Rock Springs, in the County of Sweetwater, in the State of Wyoming, is located in part of the Northeast Quarter (NE 1/4) of the South-High Section (36) of section thirty five (35) in Township 19 North (19) Range 10 West and Five East (E5) of the Sixth Principal Meridian and is designated as blocks 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16 and streets and alleys in the Union Pacific Coal Company Hospital Addition to Rock Springs and located in the county Clerk's office.

That the survey and plan thereof into lots, blocks, streets and alleys on this plat is in full compliance with the provisions of the act of Congress of the United States, approved August 10, 1906, in which the owner in fee simple thereof, subject to the reservation in deed of easements from the Union Pacific Coal Company, and that the foregoing is a correct plat of blocks 1 to 16 of the Amended Hospital Addition and that the dimensions of the lots and blocks and the widths of the streets and alleys are correctly shown on the plat by figures representing feet and decimals of a foot.

That the said Rock Springs Realty Company hereby dedicates to public use all the streets and alleys as shown on the foregoing and amended plat of blocks 1 to 16.
