



KNOW ALL MEN BY THESE PRESENTS: That the Town of Green River, Wyoming, a municipal corporation, duly organized and existing under and by virtue of the laws of the State of Wyoming, does hereby certify that the above or foregoing Mansface Addition to Green River, Wyoming, in the County of Sweetwater, in the State of Wyoming, is located in the Northeast Quarter (NE $\frac{1}{4}$) of Section Twenty seven (27), Resurvey Township Eighteen (18) North, Range One Hundred Seven (107) West, of the Sixth Principal Meridian, and more particularly described as follows, to wit:

Beginning at a point, which is the southeast corner of Mansface Addition, from whence the East one-quarter corner of Section Twenty seven (27), Resurvey Township Eighteen (18) North, Range One Hundred seven (107) West, of the Sixth (6th) Principal Meridian bears south forty nine degrees twenty minutes thirty eight seconds east ($349^{\circ} 20' 38'E$) one thousand three hundred seven and ninety one hundredths (1307.91) feet; thence south eighty four degrees thirty five minutes west ($384^{\circ} 35'W$) one thousand three hundred seventy seven and ninety three hundredths (1377.93) feet; thence north eighteen degrees fifty seven minutes east ($N18^{\circ} 57'E$) ninety nine and sixty two hundredths (99.62) feet to a point on the Green River Linwood Highway right of way line; thence north eighteen degrees fifty seven minutes east ($N18^{\circ} 57'E$) seven hundred one and seventy six hundredths (701.76) feet along said highway right of way line; thence north eighty four degrees thirty five minutes east ($N84^{\circ} 35'E$) one thousand one hundred eighteen and seventy six hundredths (1118.76) feet; thence south five degrees twenty five minutes east ($55^{\circ} 25'E$) five hundred eighty seven and eight hundredths (587.08) feet; thence south twenty one degrees nine minutes west ($52^{\circ} 09'W$) one hundred fifty nine and seventy eight hundredths (159.78) feet to the point of beginning, containing twenty one and four tenths (21.4) acres, more or less.

And that the survey and staking thereof into lots, blocks, streets, and alleys as the said Mansface Addition to Green River, Wyoming, as appears on this plat, is with the free consent and in accordance with the desires of the undersigned owners and proprietors and that it is the owner thereof, subject to the mineral reservations contained in deed issued by the Union Pacific Railroad Company, and that the foregoing is a correct plat of the said Mansface Addition and that the dimensions of the lots and blocks and

the widths of the streets and alleys are correctly shown on the plat by figures representing feet and decimals of a foot. And that the Town of Green River hereby dedicates to public use all the streets and alleys as shown on the foregoing and annexed plat.
