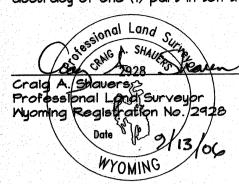
### STATEMENT OF SURVEYOR

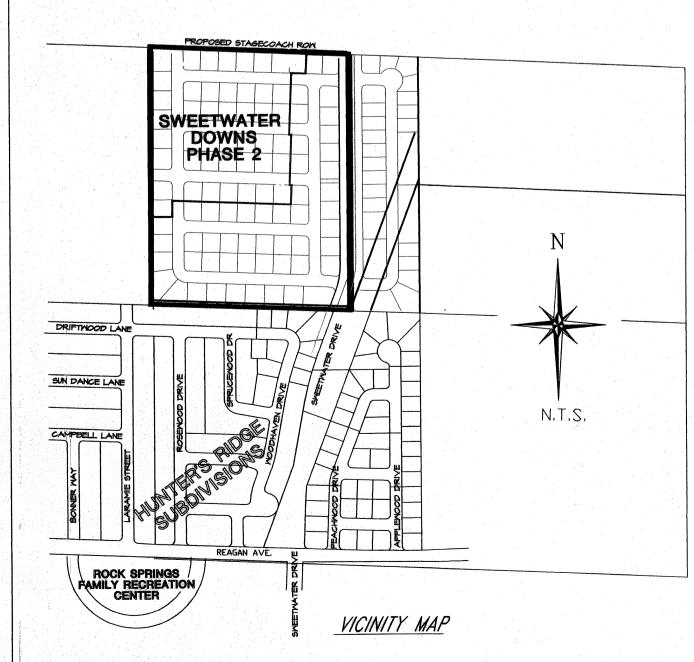

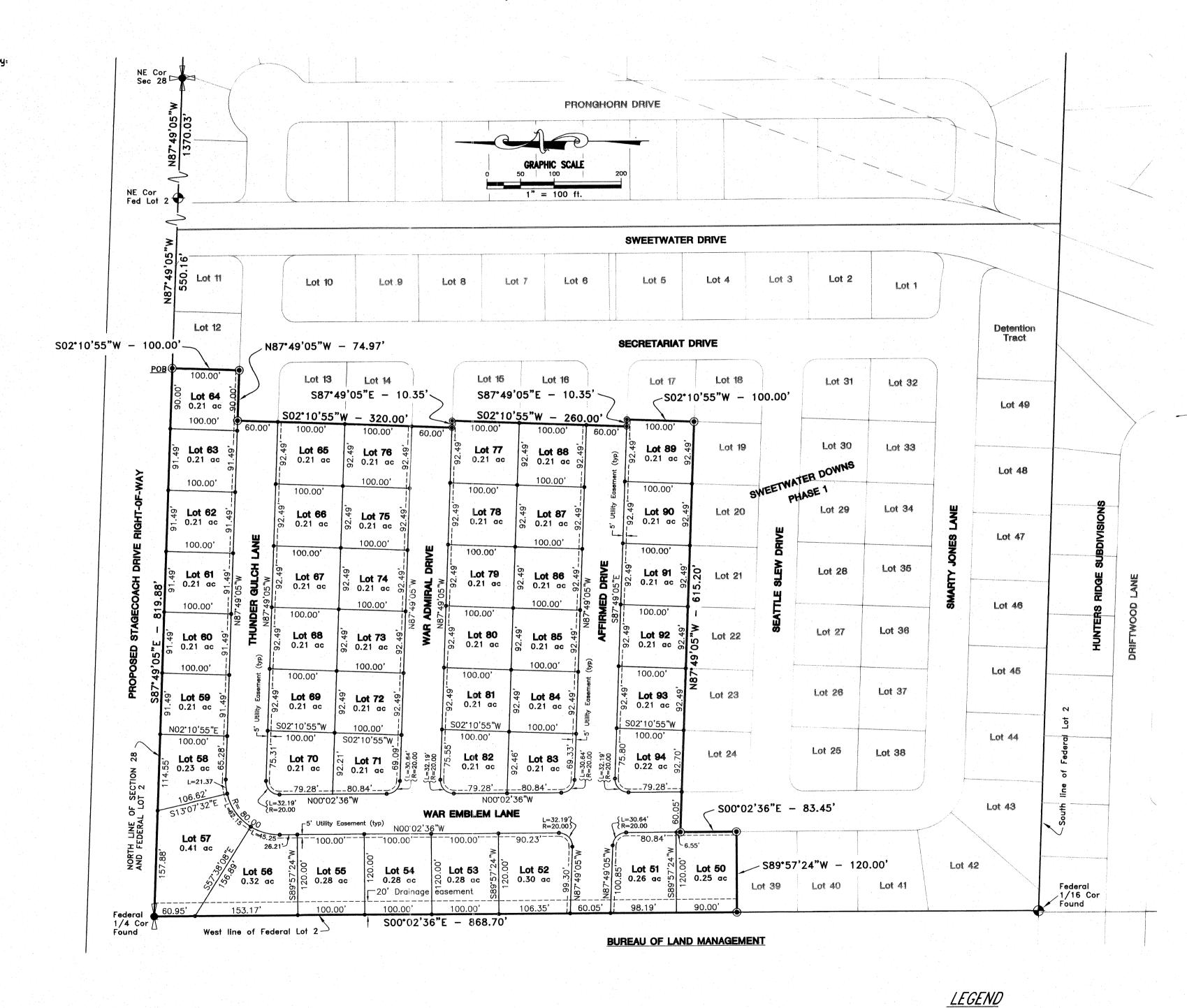

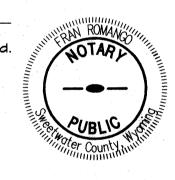
