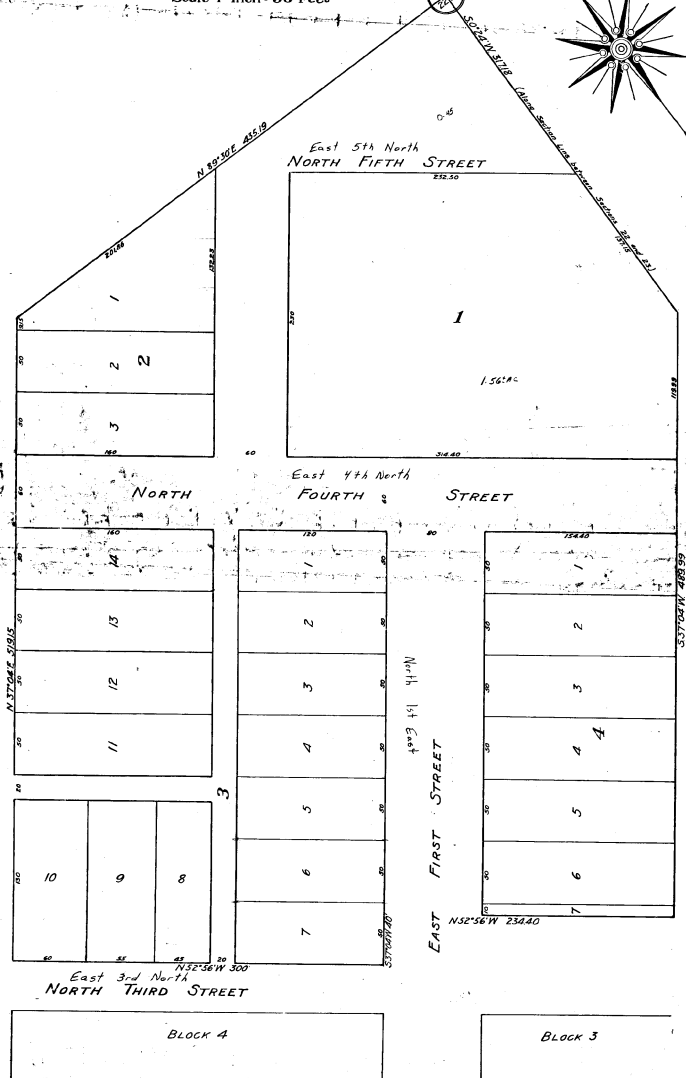
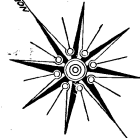

KNOW ALL MEN BY THESE PRESENTS: That School District No. 2, in the County of Sweetwater and State of Wyoming, a corporation duly organized and existing under and by virtue of the laws of the State of Wyoming, do hereby certify that the above or foregoing Washington School Addition to Green River, in the County of Sweetwater in the State of Wyoming is located in the Northeast quarter of the Northeast quarter (NE<sup>4</sup>NE<sup>4</sup>) of section Twenty Two (22) in Township Eighteen (18) North of Range One Hundred Seven (107) West of the Sixth Principal Meridian, more particularly described as follows: Beginning at the Northeast corner of section 22, T.18N. R. 107W. hence S 89°56'W 371.8 feet along the section line between 22 and 23, thence S 37°04'W 483.95 feet, thence N 52°56'W 234.40 feet, thence S 37°04'W 40 feet, thence N 52°56'W 300 feet, thence N 37°04'E 519.15 feet, thence N 89°56'E 485.19 feet to the Northeast corner of section 22, and place of beginning.

And that the survey and staking thereof into lots, blocks, streets and alleys as the Washington School Addition to Green River, Wyoming, as appears on this plat, is with the free consent and in accordance with the desires of the undersigned owners and proprietors, and that they are the owners in fee simple, hereof, and that the foregoing is a correct plat of the said Washington School Addition to Green River and that the dimensions of the lots and blocks and the widths of the streets and alleys are correctly shown on the plat by figures representing feet and decimals of a foot.
