

**KNOW ALL MEN BY THESE PRESENTS:**

That South Brothers, a partnership, the owners of the tract of land hereinafter described, do hereby certify that the foregoing South Addition to Green, Sweetwater County, State of Wyoming is located in the Southeast Quarter of the 24th and 25th Sections of Section Twenty Three (23) Township Eighteen (18) North, Range One Hundred Seven (107) East of the Sixth Principal Meridian, and being more particularly described as follows:

Beginning at a point which is located South 84° 47' East a distance of 1266.9 feet from the West Quarter Corner of the said Section 23; thence North 0° 00' East a distance of 1100 feet; thence South 52° 04' East a distance of 1847 feet; thence a distance of 1100 feet; thence South 52° 04' East a distance of 1847 feet; thence South 33° 00' East a distance of 1544 feet; thence South 34° 00' East a distance of 247.72 feet; thence South 27° 05' East a distance of 1877 feet; thence South 19° 16' East a distance of 1044 feet; thence South 37° 00' West a distance of 289 feet; thence North 25° 00' West a distance of 300.00 feet; thence South 37° 00' East a distance of 20 feet; thence North 55° 00' West a distance of 255.00 feet; the point of beginning, and thence compassed 30 acres, more or less.

And the platting thereof into the said Section is in accordance with the desire of the undersigned owners and proprietors of the above described land; that this map is a correct plat of the said addition and the dimensions, in the said plat, streets and alleys are shown hereon by figures representing feet and decimal thereof. And the said owners hereby dedicate to the use of the public all of the street and alleys shown on this plat, reserving however the rights of Union Pacific Railroad Company to mine and remove mineral deposits by underground workings thereunder in accordance with the terms of the original conveyance from said Railroad Co. to predecessor in interest of present owners.

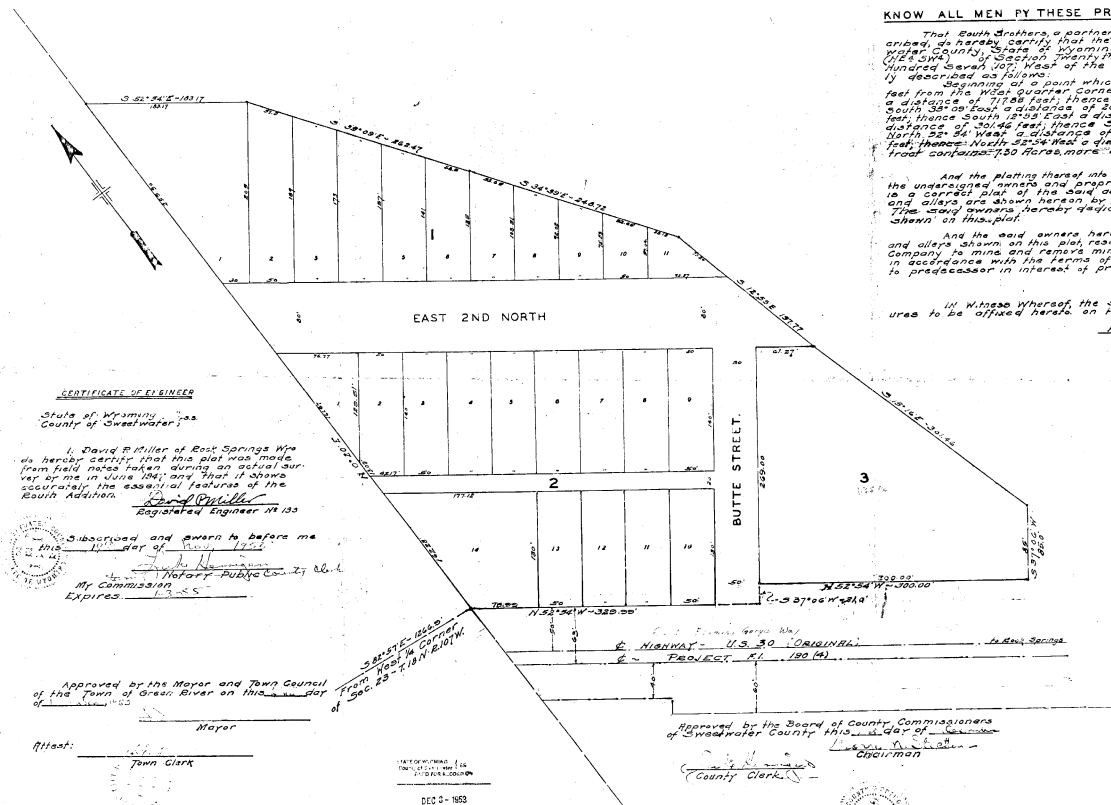
