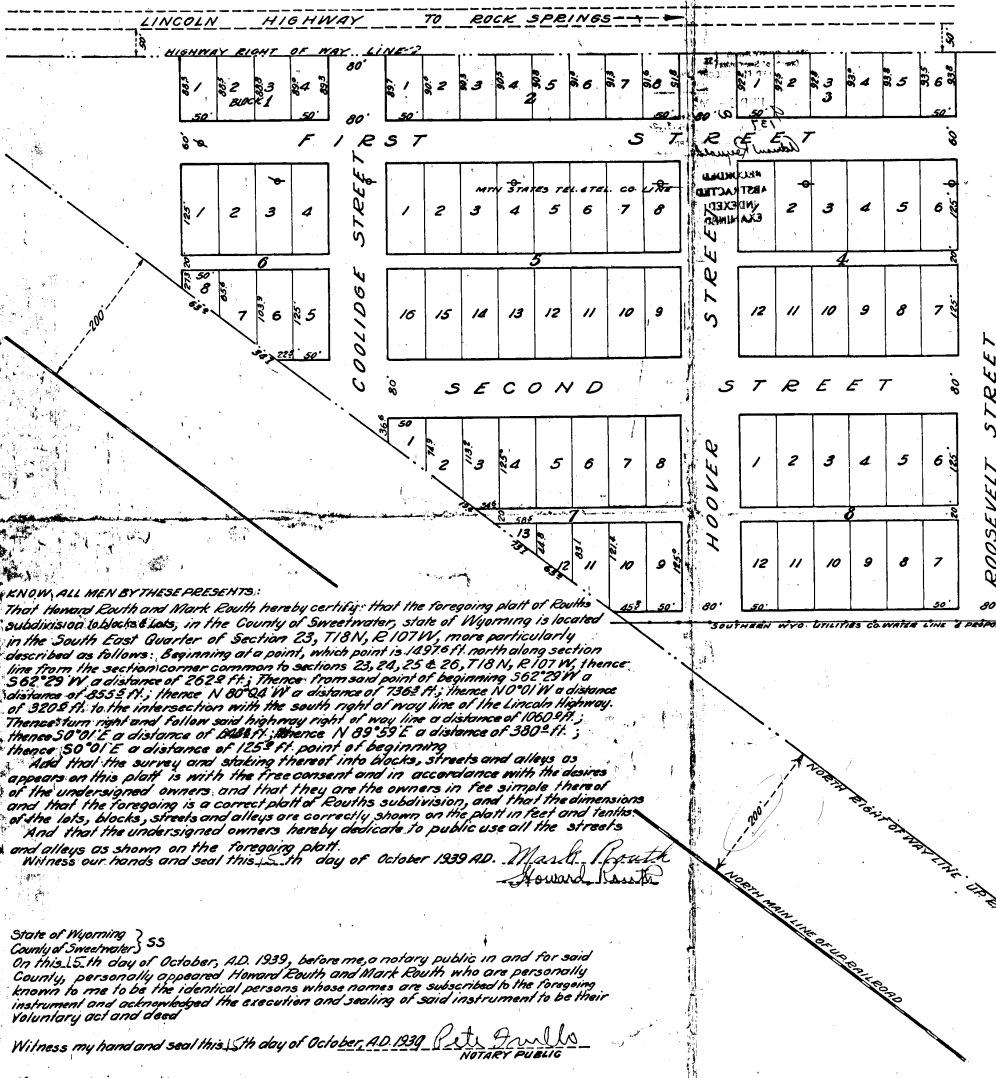
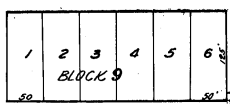


MAP OF ROUTH SUBDIVISION

 That Howard Eouth and Mark Eouth hereby certify that the foregoing plat of Routh subdivision into blocks & lots, in the County of Sweetwater, state of Wyoming is located in the South East Quarter of Section 23, T18N, R107W, more particularly described as follows: Beginning at a point, which point is 1497.6 ft. north along section line from the section corner common to sections 23, 24, 25 & 26, T18N, R107W; thence S 62° 29' W a distance of 262.8 ft.; thence from said point of beginning S 62° 29' W a distance of 855.5 ft.; thence N 80° 04' W a distance of 736.3 ft.; thence N 0° 01' W a distance of 320.8 ft. to the intersection with the south right of way line of the Lincoln Highway. Thence turn right and follow said highway right of way line a distance of 1060.9 ft.; thence S 0° 01' E a distance of 1888 ft.; thence N 89° 59' E a distance of 380.2 ft.; thence S 0° 01' E a distance of 125.3 ft. point of beginning.
