That the undersigned owners hereby certify that the Townsite of Rio Vista is located in Lots 2 and 3 and 25 1/2' NW 1/4 of Section 6, Eastover Township 18 North, Range 107 West, 6th R.M. being more particularly described as follows:

Beginning at a point on the southerly right of way line of Highway U.S. 30—said point being located South 42° 24' 55" East a distance of 3466.68 ft. from the northwest corner of the said Section 6, thence South 0° 02' West—270.22 ft.; thence South 60° 03' East—200 ft.; thence North 0° 02' East—117.70 ft. to a point on the highway right of way line; thence Northwestward along the arc of the curve defining the right of way line; the radius of which is 11559.2 ft.; a distance of 24.43 ft.; thence North 77° 13' West—399.19 ft. to the point of beginning. Said tract has an area of 111.14 acres, more or less.
