



**KNOW ALL MEN BY THESE PRESENTS**

That the Town of Green River a municipal corporation organized and existing under the laws of the State of Wyoming, do hereby certify that the Mountain Fuel Addition to the Town of Green River Sweetwater County, State of Wyoming, as located on the East half (1/2) of the Northeast Quarter (NE 1/4) of Section Twenty seven (27), and the West half of the West half Quarter (1/2) of the West half (1/2) of the East half of Township Eighteen (18) North Range One hundred and one (101) West 24th Principal Meridian, are being more particularly described as follows:

Beginning of a point on the section line corner to the above Section 26 and 27, said point being located, thence 215.00 feet from the common quarter corner of the said sections, thence North 80°10' East - 350.00 feet, thence North 0°20' West - 300.00 feet, thence South 80°10' West - 350.00 feet, thence North 2°11' East - 370.00 feet, thence North 7°07' West - 350.00 feet, thence South 87°00' West - 300.00 feet, thence South 87°00' West - 300.00 feet, thence North 80°10' East - 350.00 feet, thence South 80°10' East - 350.00 feet, thence South 80°10' East - 350.00 feet to the point of beginning, said parcel contains 13.40 Acres, more or less.
