



KNOW ALL MEN BY THESE PRESENTS

That the Town of Green River, a municipal corporation organized and existing under the laws of the State of Wyoming, does hereby, by its Mayor and Town Clerk, add to the Town of Green River, Sweetwater County, State of Wyoming, a tract in the East half (E½) of the North East Quarter, Section Twenty Six (26), in the said Township Eighteen (18) Range One hundred and forty seven (147) West, Principal Meridian, and being more particularly described as follows:

Beginning at a point on the section line common to the above described tract and the common quarter corner of the said sections, thence North 85° 10' East 326.00 feet; thence North 85° 10' West 326.00 feet; thence South 85° 10' West 326.00 feet; thence North 85° 10' East 326.00 feet; thence South 85° 10' West 326.00 feet; thence South 85° 10' East 200.0 feet; thence North 85° 10' East 326.00 feet; to the point of beginning, said parcel containing two acres, more or less.

And the aforesaid tract, together with all blocks, streets and alleys, as the said Mountain Fuel Addition to the Town of Green River, Wyoming, as appears upon this plat, is with this free grant, and the same is to be held and used by the said company, or its assigns, as the sole proprietor of the herein described lands, ownership subject to mineral rights, and is to be held and used by the said company, or its assigns, as the sole proprietor that this is a correct plat of the said addition, and the dimensions of the lots, blocks, streets and alleys, and the boundaries shown herein by figures representing feet and fractions of a foot.

And that the undersigned owner hereby dedicates to the public use all of the streets and alleys shown herein.
