KNOW ALL MEN BY THESE PRESENTS

That the Town of Green River, Wyoming, a municipal corporation duly organized and existing under and by virtue of the laws of the State of Wyoming, do hereby certify that the foregoing Hoover Addition to Green River County of Sweetwater, State of Wyoming, is located in the Southeast Quarter of the Northwest Quarter (SW¼NW¼) of Section Twenty-three (23), in Township Eighteen (18), North, Range One Hundred-seventy (107), West, Sixth Principal Meridian, and is more particularly described as follows:

Beginning at the Northeast corner of the Union Pacific First 1919 Addition to the Town of Green River which is a point of beginning at the Northwest corner of the Southwest Quarter of the Northwest Quarter (SW¼NW¼) of said Section Twenty-three (23); thence East, along the north line of the said Forty (40) acre tract to a point which is forty (40) feet distant northeasterly at right angles from the extension southeasterly of the northeasterly right angles from the extension southeasterly parallel with and perpendicular to the extension southeasterly of the north line of Block Two (2); in the Original Town of Green River as said line of Block Two (2); to a point which is seven hundred twenty (200) feet distant northeasterly at a right angle from the extension southeasterly of the north line of the said Block Two (2); to a point which is seven hundred twenty (200) feet distant southeasterly at a right angle from the extension southeasterly of the north line of the said Block Two (2); thence southeasterly, along the extension of the north line of the Union Pacific First 1919 Addition, to a point which is Three Hundred Sixty (360) feet distant; thence Southwesterly, parallel with and 360 feet distant southeasterly at right angles from said southeasterly boundary line of the Union Pacific First 1919 Addition, to a point which is Seven Hundred Sixty (760) feet distant; thence northwesterly to a point on the southeasterly line of the Union Pacific First 1919 Addition which is Seven Hundred Sixty (760) feet distant; thence southeasterly on the southeasterly line of the said Union Pacific First 1919 Addition; from the northeast corner of the said Union Pacific First 1919 Addition, thence east corner of the said Union Pacific First 1919 Addition, on the northeasterly line of the said Union Pacific First 1919 Addition to the point of beginning.

And that the survey and staking thereof into lots, blocks, streets and alleys as said Hoover Addition to Green River Wyoming, as appears on this plat, is with the free consent and in accordance with the desires of the undersigned owners and proprietors, and that the foregoing is a correct plat of the said Hoover Addition, and the dimensions of the lots and blocks on the width of the streets and alleys are correctly shown on this plat by figures representing feet and decimals of a foot.

And that the said Town of Green River hereby dedicates to public use all the streets and alleys as shown on the foregoing plat.
